 - Latest information from WIAA-**WIAA Staff Covid Issues:**
 - Passed that Gymnastics coaches may not coach athletes on equipment from Sept 28-Nov. 30.
 - No competitions may happen between Sept 28 and Nov. 30.
 - Pre-participation in all sports reduced in half except for football and gymnastics which will be 10.
 - Cheer: Online safety course is available from USA Cheer. Board will extend certification to three years.
 - Bowling teams will consist of four bowlers for this season. Once assigned a lane, no substitutions allowed. Matches will consist of either 2 or 3 regular games, no Baker games.
 - It is recommended that athletic trainers or medical personnel be at each district level event.

 - HB 1660 ASB Info-Bryan Streleski Reviewed basics of bill. Lots of questions regarding overall impact on ALL ASB activities.

Football: Bryan Streleski and Joe Keller will schedule meetings with District football commissioners to work out schedules.


