Meeting called to order by President Brian Smith at 11:03.

- Pledge of Allegiance/Introductions: WIAA Staff: Justin Kesterson, Cindy Adsit BS**
- Celebrations: In-person meeting today! Kudos from Jerry Peterson to Jim Meyerhoff for hosting great 3A/4A State football championships at Sparks Stadium. GK 4A State FB Champions, too. Suzanne Vick cited a supreme act of sportsmanship as GK and Olympia's VB teams sat behind the Curtis bench and cheered them on to a 2<sup>nd</sup> place finish at the State tournament. That is what sportsmanship is all about!**
- 11-1-21 Minutes Approval ACTION REQUIRED-BS DOC #2 M/S/P**
- Treasurer's Report: SP/JK ACTION REQUIRED-BS**
  - Budget Status Reports, Bank Reconciliation, Columbia Bank Statement and approval of checks, December, 2021 **M/S/P**
    - Overall tournament financial summary. **Stark Porter presented the November budget and balanced the budget with Columbia Bank "to the penny." The Quickbooks account is off \$200, but Stark is confident he will solve it.**
    - GoFan deposit issue; problem is with Columbia Bank, not GoFan. Security measures with CB and a \$15,000 (approx.) deposit. CB sent the deposit back to GoFan, due to some security blocks, which Keller and Porter cleared up. It seems odd that a deposit would be denied as a security risk. It is straightened out and the new deposit is being made any day.**
- Director's Report: JK**
  - Board Passes issued to new members; Vick and Streleski both indicated that they needed the passes as well. Keller will issue soon.**
  - Board Apparel:** all-weather jackets from Rush Team Apparel will be hopefully ready by January 10 meeting. **Noted**
  - Rush Team Apparel** is looking to pay an organization or individuals during district events to help print, distribute or whatever is needed.
  - Winter sport commissioner meetings** WCD Commissioners, please review the "responsibilities" with your individual league commissioners. Some confusion exists about what people are responsible for. **DOC #3 Reviewed.**
    - Tournament forms are on the WCD site (finally) under "Forms." Make sure if you are a host, or someone in your league is hosting, they are aware and using the forms. Link: <http://www.wiaadistrict3.com/index.php?pid=3.0.0.0.106> **Noted.**
    - Advance Information Bulletin or Syllabus?** We need common language and common format. **Syllabus was approved by vote.**
      - Tournament Directors are responsible for these if hosting.
  - Keller will have a **Google Form** next meeting that you will fill out a couple days before the Board meeting, in which general info can be listed, shared and reviewed prior to the Board meeting. We can ask if there are questions or comments over some of the general info. If so, we will address it at the appropriate time in the agenda. If not, we can move on and it will be noted in the minutes. We may be able to save time in the Board meetings. We can try it and see what happens. **Noted.**
  - Grants for WCD Board:** Jim Catalinich, retired Stadium AD and former WCD Board member, sent me info on possible grants we may be eligible for. We will work together to see if we can secure a grant or two, which will improve our finances significantly. Jim is a lawyer and has some experience in writing grants. Stay tuned. **M/S/P giving permission to Keller to pursue Grants with Jim Catalinich's help. One area that the grants may help is freeing up some dollars to raise the volunteer stipends for people who work the WCD events. It is getting harder to find people to volunteer for the stipends offered, especially in these COVID times.**
- Violation/Ejection Report: JM M/S/P**
  - Mark DeJonge will share a document summarizing the Nisqually League's actions against Life Christian for repeated football violations. It will also include LCA's actions to remedy the situation. Mark is to be commended for his leadership in the process.**
- WIAA Report-DJ/WM/WIAA Staff**
  - Latest COVID Guidelines-info: Justin and Cindy shared that the WIAA is working with the DOH and the state to relax the multiple testing times required for students and athletes in schools. We are being held to a higher standard than anyone else, and the incidents of infections are minute in the big scheme of things. The two entities seem to be listening.**
  - Update on Winter Tournament schedules and Fall tournament outcomes. **Fall tournaments ended up successfully.**
  - Other: **Strategic Planning meeting is occurring Tuesday, 12/7/21 at the WIAA office.**

**8. Discussion/Action Items BS/JK/DJ**

- A. Winter sports facilities and COVID restrictions, specifically seating capacity. **BS/JK/BW** Kevin Alfano shared that superintendents in the WCD feel that school districts are being held to a higher standard, and this has been shared with legislators by the Supt. Group, who seems to be listening.
- B. **Sportsmanship Committee: BS-Committee** Suzanne Vick shared that a company named “Biggest Fans” has developed a program which gives students some positive alternatives for team support at athletic contests. Suzanne will approach the company about possibly presenting to leagues and the WCD to possibly help us build more positive sportsmanship behaviors.  
-Brian Smith also brought up that some of the student leaders from the sportsmanship summit indicated a level of frustration when their student section is following the positive guidelines, yet visiting teams come in, or when their visits another school, poor sportsmanship behaviors are rampant and allowed. It makes the positive students question their efforts to be stewards of good sportsmanship.
- C. Gymnastics Facility needed for District Tournaments **BS, JK** Dwayne Johnson shared the frustration and problems with not having a facility for District gymnastics, then not having officials available due to college and other tournaments occurring that same weekend. Steve Taylor said he would ask his coach to reach out to Auburn Gymnastics in Dupont to see if they can accommodate us. Some leagues will also forgo sub-district tournaments and go straight to Districts. This is a work in progress.
- D. Amendment timeline Noted.
  - 1. January 24: Winter Coalition (virtual)
  - 2. April 27 – May 6: Representative Assembly voting period
  - 3. Last year monthly Zoom meetings were held for Rep Assembly members, presenters and anyone interested in the amendments and process. The focus was for voting members to dialogue regarding questions and comments they receive while discussing with their individual boards.
